New Date – When is it?

Given the recent Government advice and growing concerns around Covid-19, we believe it is in the best interests of all our guests to postpone the event from 9 July until the Autumn.

We are very pleased to announce the CN Awards 2020 will now take place on **Wednesday 14th October at the Grosvenor House Hotel, London.**

The timings have changed and the awards will now take place over lunch. You will be contacted again shortly by Will Botting, Event Manager who will confirm details.

What happens to the booking we have made to attend?

All bookings will automatically be transferred to the new date. No action is required on behalf of the table-booker for your organisation. CN will reach out to the person who booked to attend to advise them of the plans moving forward, and that person will then be responsible for providing a new, updated and relevant guest list closer to the time.

We are currently unfortunately unable to offer refunds on the packages purchased to attend the awards.

What about my accommodation/travel/expenses?

It is with regret that CN and emap are unable to offer any remuneration for expenses already incurred, including accommodation and travel.

Will the winners stay the same?

Yes. The integrity of the awards is of the upmost importance and details of said winner and highly commended entrants will remain secret until the awards take place on their new date which is **Wednesday 14th October 2020.**

If I can't make the new date, can I nominate others to attend in my place?

Yes, definitely. The places you/your organisation have purchased to attend are subject to the same flexibility as before. CN will be in touch with your organisation's lead contact a month or two prior to the rescheduled date and will ask them to provide a brand new guest-list so that we can be sure it is as up to date as possible.
